

Information on the processing of personal data of contractors who are natural persons

Bespoke sp. z o.o., as the controller of personal data of contractors who are natural persons (including entrepreneurs, attorneys-in-fact), on the basis of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC, hereinafter the GDPR, presents below the information concerning the processing of your personal data in connection with the conclusion and performance of a contract with the Controller:

2. Purpose of personal data processing:
 - the conclusion and performance of a contract with the Controller (based on Article 6(1)(b) of the GDPR)
 - the performance of legal obligations incumbent on the Controller (based on Article 6(1)(c) of the GDPR)
 - the purposes resulting from the legitimate interests pursued by the Controller (based on Article 6(1)(f) GDPR) consisting of:
 - a) drawing up statements, analysis and statistics for the Controller's internal needs, which includes reporting and service development planning,
 - b) conducting marketing of services provided by the Controller,
 - c) establishing, defending and asserting claims related to the contract with the Controller.
3. Data recipients:
 - persons authorized by the Controller who are their employees or who provide services for them under civil law contracts,
 - postal and courier operators - if there is such correspondence,
 - entities providing consulting, advisory, auditing, legal, tax and accounting assistance to the Controller.
4. Data storage period:

The duration of the contract with the Controller, and to the extent related to the defence or assertion of claims, until the limitation period for claims related to the contract with the Administrator expires. The Controller may keep personal data longer, but only for legitimate reasons, if the law allows or mandates such storage (e.g., for financial settlements in accordance with tax and accounting regulations).

- does not make a decision that is based solely on automated processing of personal data,

 - providing personal data is voluntary, but failure to do so will prevent the conclusion of a contract with the Controller,
 - You have the right to:
 - request from the Controller access to your personal data,
 - rectify your personal data, delete (which applies to data processed not for the purpose of fulfilling a legal obligation imposed on the Controller) or restrict data processing,
 - data portability, i.e. the right to receive from the Controller and send on your own to another Controller your personal data in a structured, commonly used machine-readable format and the right to request that your personal data be sent directly by the Controller to another controller, if technically possible,
 - object to the processing of data in accordance with Article 21 of the GDPR,

 - conducting marketing of services provided by the Controller,
 - establishing, defending and asserting claims by the Controller related to the contract with the contractor.
 - if applicable - performance of legal obligations incumbent on the Controller (based on Article 6(1)(c) of the GDPR).

 - persons authorized by the Controller who are their employees or who provide services for them under civil law contracts,
 - postal and courier operators - if there is such correspondence,
 - entities providing advisory, consulting, auditing, legal, tax, accounting and administrative assistance to the Controller.

The duration of the contract between the Controller and the contractor, and to the extent related to the defence or assertion of claims, until the limitation period for claims under the contract between the Controller and the contractor expires. The Controller may keep personal data longer, but only for legitimate reasons if the law permits such storage.
